## **Meeting Minutes/Summary:**

1) Bruce Willms gave a presentation on Automated Cataloging. See his PowerPoint for content of the presentation. The group is aware that OCLC is already pursuing these options with the Next Generation pilot and is eager to learn more about the specifics of that effort.

Questions and Discussion: Are publishers/vendors already using ONIX? How will data mining from WorldCat enrich publisher data? How will the Next Generation pilot deal with totally new works? What about authority control --- is this part of the Next Gen pilot? One person compared records prepared from ONIX data prior to publication to CIP records. Will this data appear in WorldCat Local?

2) Tony Ferguson presented on the topic "Opening a Cataloguing Factory in Asia". Consult his PowerPoint for the content of his presentation. His proposal is that OCLC consider partnering with Asia's developing countries to open one or more cataloging factories in Asia. CJK and English, as well as other Asian languages could be cataloged, both print and electronic titles.

Questions and discussion: Tony has 2 cataloging factories at his library. He is not selling copy to others. He believes the contributions to OCLC and the credits his library receives from OCLC are more valuable. The cooperative cataloging model is crucial. One US librarian commented that they use graduate students to catalog CJK, and thus their costs per title are lower that Tony cited.

Tony was asked what the benefit to OCLC would be of opening such a factory in Asia? He stated that guaranteeing quality of work would be a huge benefit to the OCLC membership, as well as the low cost of labor in developing countries. He believes there would be sufficient volume if cataloging of ebooks, and sets of materials is explored.

In reference to the earlier discussion, it was clarified that ONIX is only in use for Western languages currently. Many remarked that the challenge was to catalog unique materials, and questioned whether it would be cost effective to do that using a cataloging factory.
