## 1 What is OCLC Connexion?

### OCLC Connexion

OCLC Connexion® is your access to the OCLC system for cataloging. Two interfaces are available, the Microsoft® Windows-based software client ("the Connexion client") and a browser-based interface ("the Connexion browser"). See separate documentation for the Connexion browser at: <http://www.oclc.org/support/documentation/connexion/browser/>.

Both interfaces offer complete cataloging functions. Each also offers unique features.

For example, the client provides support for the following non-Latin scripts for cataloging:

- Arabic
- Bengali
- Chinese
- Cyrillic
- Devanagari
- Greek
- Hebrew
- Japanese
- Korean
- Tamil
- Thai

OCLC Connexion is available 24 hours, Monday through Sunday.

**Note:** OCLC occasionally conducts maintenance on the system, most usually on Sundays from 2 am to 6 am U.S. Eastern Time. OCLC usually provides advance notice about these maintenance periods via listserv messages and on the system alerts Web page at <http://www.oclc.org/support/systemalerts/>.

### Cataloging functions in both Connexion client and browser interfaces

Catalogers can use either the client or browser interface to Connexion for the following functions:

- Search WorldCat online
- Create and edit bibliographic records, including constant data
- Open MARC field Help from *Bibliographic Formats and Standards* for immediate field descriptions as you catalog
- Use authority records and control headings in bibliographic records
- Take OCLC actions on records
- Take OCLC actions on multiple records selected in a list

- Export records
  - Print labels
  - Import records
  - Open OCLC system news
  - Report errors in bibliographic and authority records to OCLC quality control staff
  - Search the Library of Congress (LC) authority file
  - Complete Name Authority Cooperative Program (NACO) activities
  - Conduct peer reviews of records
  - Open a WebDewey-only session
  - Access your library's OCLC usage statistics
  - Insert data from cited records automatically
  - Select validation options for setting holdings and exporting
  - Open a local holdings maintenance browser window to maintain local holdings records for WorldCat records
  - Catalog electronic resources by automatically extracting metadata and creating a preliminary workflow
  - Search for superseded LC authority history records; opening LC distributed authority record from a history record and vice versa
  - Open guided entry windows to edit or insert fields 006, 541, or 583
  - Display a record in a "Find in a Library" view in WorldCat.org
  - Export bibliographic records using either MARC 21 (default) or one of the following Dublin Core record standards
    - For export, select Dublin Core Qualified, Dublin Core Simple, OCLC Dublin Core Qualified, or OCLC Dublin Core Simple
    - For import, select Dublin Core Qualified or Dublin Core Simple
- Note:** Dublin Core standards are structured in XML
- Access institution records attached to master records for additional cataloging data
  - Access SCIPIO records describing art and rare book sales catalogs for sales from the late sixteenth century to the present

**Additional cataloging functions available only with the Connexion client**

Catalogers can use the following functions in the client only:

- Catalog offline and online
- Use local save files (located on your workstation or shared drive) as well as your library's online save file

- Create local constant data records, as well as online constant data, to insert often used MARC-formatted content
- Validate records offline
- Batch process WorldCat and LC authority file searches
- Batch process OCLC actions on records, including exports and label printing
- Batch process setting or deleting holdings by OCLC number without first downloading the records
- Create text strings to insert frequently used data
- Write macros using client-specific commands to automate frequent tasks  
Or  
Use a macro recorder to create macros automatically
- Use the client's built-in label printing capability
- Print local accessions lists
- Create multiple user profiles (sets of client options) to catalog for more than one library
- Check spelling in records
- Choose a language for the client interface in addition to English: select Chinese (simplified or traditional), English, German, Japanese, Korean, or Spanish
- Use Arabic, Bengali, Chinese, Cyrillic, Devanagari, Greek, Hebrew, Japanese, Korean, Tamil, and Thai scripts for cataloging
- Automatically transliterate romanized data in Arabic and Persian records to Arabic script data (two ways)
- Validate MARC-8 characters separately from record validation
- Convert invalid CJK characters to MARC-8 automatically
- Search the Hong Kong Chinese Authority Names file (read-only access)
- Upload digital files to a CONTENTdm collection and automatically add field 856 to the WorldCat record that contains the URL to open the digital content (for authorized CONTENTdm users with correct setup only)
- Customize WorldCat search and browse index lists
- Define a startup action or macro to run each time you open the client
- Use quick tools for entering command line WorldCat searches and for using and managing text strings and user tools
- Drag and drop to reposition toolbars or to reposition buttons on the main client toolbar
- Set up a Z39.50 access to your library's integrated local system (ILS) to retrieve local bibliographic records
- As an alternative to the client function for inserting diacritics and special characters, use an RLIN21 Latin keyboard

- As an alternative to using Windows keyboards or IMEs for entering Arabic, Cyrillic, and Hebrew scripts, install and use RLIN21 keyboards for these scripts
- Add variant name headings using MARC-8 non-Latin character sets to LC authority file records

## 2 Hardware, software, and user requirements

<b>Hardware</b>	See specifications outlined by Microsoft for your version of Windows.
<b>Windows operating systems supported</b>	<p>The Connexion client is supported for use with 32- and 64-bit versions of the following Microsoft Windows operating systems:</p> <ul style="list-style-type: none"><li>• Windows XP (Home and Professional editions)</li><li>• Windows Vista</li><li>• Windows 7</li></ul> <p>(For Vista and Windows 7, see exception below for unsupported viewing of some legacy topics in client Help.)</p>

**Disk space** Minimum hard-disk space required for the Connexion client: 70 MB.

### Notes:

- You may already have .NET Framework 4 Extended on your workstation. To check whether it is already installed:

In Windows, go to **Start menu > Control Panel, Add or Remove Programs [or Programs and Features]**. Look for *Microsoft .NET Framework 4 Extended* in the list of installed programs.

- You may already have Microsoft .NET Framework 4 Client Profile installed on your workstation. However, the **Client Profile version of .NET 4 alone is insufficient** to support Connexion client. You must have the Extended version.
- It is fine to have previous versions of .NET installed on your workstation simultaneously without causing any problems with running the client. The client automatically uses the version of .NET that is needed.

### Installing the client for the first time

If you have never installed the Connexion client before installing version 2.40, and .NET Framework 4 Extended is not already on your workstation, you may want to consider installing it ahead of time to make the client 2.40 installation faster.

### User level requirements for installing

Logon with local administrator-level privileges is either required or highly recommended for installing the client as noted in the following list of circumstances:

- **Required for installing .NET Framework 4 Extended.** Whether you install .NET Framework separately or with Connexion client complete software, under any supported Windows operating system, you must log on with local administrator privileges.
- **Required if you use Windows Vista or Windows 7.** For these operating systems, you must log on with administrator level privileges to install any software program.
- **Recommended if you use Windows XP. You may be able to install the Connexion client-only software with lower level privileges,** depending on your particular work setup, but OCLC highly recommends that you install with administrator privileges.

**Tip:** If you have Windows Vista or Windows 7, after you save the download file, right-click the \*.exe installation file, and click **Run as administrator** to help prevent possible problems with installing. This tip is included in the next section of this Guide in step 7 of the instructions for downloading and installing.

### Internet connection required for some functions

An Internet connection is required for the following functions:

- **Client log on.**  
You must have a TCP/IP Internet connection to log on to the OCLC system from the client. You can use these access methods:
  - OCLC Default (<http://connexion.oclc.org>) (appropriate for most users)
  - Other URL (you enter a URL)

For more information, see the “Set up communications and log on” section in this Getting Started guide.

- **Offline record validation.**  
Although you do not need to be logged on to the OCLC system to validate records offline, your workstation must have Internet access for validation to work when you are offline.
- **Creating records for electronic resources.**  
An Internet connection is required to use **Cataloging > Create > Extract Metadata**, a feature that creates records by automatically extracting data from electronic files.
- **Automatically transliterating Arabic script in Arabic or Persian records while offline.**  
An Internet connection is required to use **Edit > Transliterate > Arabic** [or **Persian**] to transliterate existing romanized data (Latin-script-equivalent data) in records to equivalent Arabic script data.
- **Attach digital content.**  
An Internet connection is required to use **Edit > Attach Digital Content**, a feature for attaching electronic files to WorldCat records and entering the digital content directly into CONTENTdm collections (available only to authorized CONTENTdm users).

<b>Internet Explorer Web browser</b>	<p>The client requires that you have Internet Explorer (IE) Version 5.5 or higher installed on your workstation. IE does not need to be your default Web browser. It is not actually started when you use the client, but it must be installed for both the client and the client Help to work properly.</p>
<b>Fonts for printing records and labels</b>	<ul style="list-style-type: none"><li>• The client default font for printing records and lists is either the <b>Arial Unicode MS</b> font, if it is installed, or the default Windows font on your workstation.</li><li>• OCLC recommends that you have the Arial Unicode MS font installed on your workstation for access to the set of diacritics and special characters adopted by the American Library Association (ALA) for use in Latin script MARC records.</li><li>• This font is included with many Microsoft applications, including Microsoft Office XP, Vista, and 7, but it may not be automatically installed with these Microsoft applications. For installation instructions, run one of the Microsoft applications such as Word. Go to Help (<b>Start &gt; Help [or Help and Support]</b>) and search for <i>Arial Unicode MS</i>. Other Unicode-based fonts may also work in the client.</li><li>• The client default font for printing labels is the <b>ALA BT Courier</b> font, which is installed with the client software. OCLC recommends this font for printing labels.</li><li>• Font settings for printing records, lists, and labels are in <b>Tools &gt; Options &gt; Fonts</b>.</li></ul>
<b>Languages for non-Latin script cataloging</b>	<p>If you use non-Latin-based scripts for cataloging and use English as the default language on your workstation, you may need to install other appropriate languages and input keyboards or Input Method Editors (IMEs) on your workstation in Windows.</p> <p>Please note that the exact path to opening this functionality may vary slightly from one Windows operating system to another. See Windows Help for information specific to your Windows version (<b>Start &gt; Help [or Help and Support]</b>). See also the section titled “Windows provides input methods for using non-Latin scripts” in “International Cataloging” at <a href="http://www.oclc.org/support/documentation/connexion/client/international/">http://www.oclc.org/support/documentation/connexion/client/international/</a>.</p> <p><b>Alternative for some scripts:</b> Download and install RLIN21 keyboards for entering data in Arabic, Cyrillic, or Hebrew script (see section 4 of this Guide).</p>
<b>Interface language display</b>	<p>The client provides Chinese (simplified or traditional), English, German, Japanese, Korean, and Spanish interfaces (<b>Tools &gt; Options &gt; International</b>). If you select Chinese, Japanese, or Korean, you must have an input method installed for the language or you must use a Chinese, Japanese, or Korean version of Windows for the interface to display correctly.</p>
<b>Windows Vista and Windows 7 do not support viewing older Help files</b>	<ul style="list-style-type: none"><li>• The main Connexion client Help file (<b>clienthelp.chm</b>) works well in all supported Windows operating systems.</li><li>• However, a few peripheral legacy client Help files (<b>*.hlp</b>) run on a Help engine that Microsoft no longer supports for Windows Vista or Windows 7.</li></ul>

- The affected parts of client Help are:
  - Context-sensitive Help topics specifically for export settings windows
  - OML and Basics Help for macros (**osbi5x.hlp**)
  - Macro Editor Help (**osbi5x.hlp**)

**Note:** Help topics on client-specific macro commands **are not affected**. These topics are in the main Help file, **clienthelp.chm**.
- If you use the client with Vista or 7 and need to continue using Help topics or files listed above, you must download and install the **WinHlp32.exe** Help engine. See details and instructions from the Microsoft Web site: <http://support.microsoft.com/kb/917607>

### Notes for macro users who have newer versions of Windows

If you have Windows 7 Professional (64-bit) or Windows 7 Enterprise (32-bit) or other newer versions, you may need to move your **\macro** directory after upgrading or installing version 2.40 of the client.

In previous versions of the Client, Windows may have stored your macros in a Virtual Store. The Virtual Store is something Microsoft created to allow backward compatibility for old applications that need to write to the Program Files directory. With Vista, Microsoft stopped allowing Standard User-level users to write anything under the Program Files directory. When the Connexion client tries to write to the **\Macros** directory, Windows writes the data to the following directory instead, for example: **X:\Users\<username>\AppData\Default (or Local)\VirtualStore\Program Files(x86)\OCLC\Connexion\Macros**, where **X** is the letter of your hard drive.

Connexion client 2.40 has included an application manifest which informs the Windows operating system what permission level the client needs. The value is set to Highest Available to allow the highest access level possible without requiring Administrator privileges. Inclusion of this manifest also disables the use of the Virtual Store. If you edited macros in previous versions of the client, those changes will not be visible in version 2.40 until you copy them from the Virtual Store back to **X:\Program Files\OCLC\Connexion\Program\Macros**:

1. With the Connexion client closed, navigate to your Virtual Store using Windows Explorer. This may be a slightly different location depending on what version of Windows you are running (and whether it is 32-bit or 64-bit), but the location will be something like one of the following:
  - X:\Users\<username>\AppData\Default\VirtualStore\Program Files (x86)\OCLC\Connexion\Macros
  - X:\Users\<username>\AppData\Local\VirtualStore\Program Files\OCLC\Connexion\Macros
  - "X:\Users\<username>\AppData\Roaming\VirtualStore\Program Files\OCLC\Connexion\Macros
2. Press and hold <Ctrl> while you select all of the **\*.mbk** files within that directory (except the **OCLC.mbk** and the **Dewey.mbk** files, which are OCLC-provided macro books).
3. Press <Ctrl><C> to copy them.

4. Navigate to the **Macros** directory created by the Connexion Client installation (for example, X:\Program Files\OCLC\Connexion\Program\Macros).
5. Press <Ctrl><V> to paste the macro books to this directory.
6. Open the Connexion Client and click **Tools > Macros > Manage**. Your macro books should now be listed and available for use in the Macro window.

In addition, non-Administrator-level users may not have permission to "write" to the X:\Program Files\OCLC\Connexion\Program\Macros directory. If this is the case, change the security permissions to allow "write" privileges:

1. Open Windows Explorer, navigate to X:\Program Files\OCLC\Connexion\Program\Macros, and right-click the **Macros** folder.
2. On the popup menu, click **Sharing and Security**, and select the **Security** tab.
3. In the **Group or user name** list, highlight the user you want to change.
4. In the **Permissions...** list, click to select the **Allow** check box for **Full Control**.
5. Click **OK** to save the setting.

### 3 Download, install, and start the Connexion client

#### Overview

This section explains how to download Connexion client files from the OCLC Web site and install the program.

**If you are upgrading from a previous version**, please read the “Update the Connexion client” section before you upgrade.

#### General procedure

1. Download a self-extracting, compressed file (file extension **\*.exe**) from Product Services Web at <http://psw.oclc.org>.

Save the file to a folder on your workstation or save to a folder on a server to install to multiple workstations.

2. Uncompress the downloaded file to install.

The client extracts the files you need and starts setup. You do not need special software to uncompress.

#### Caution: Before you install, follow this checklist

- **Uninstall your current version of the Connexion client before upgrading to a new version.**


See instructions for uninstalling below. Uninstalling does not remove or change your option settings, customizations, or data files (except, see the Caution about macro books in the “Update the client” section).

See the client known problems Web page ([http://www.oclc.org/connexion/support/client\\_known\\_problems.htm](http://www.oclc.org/connexion/support/client_known_problems.htm)) and click the link “Upgrading the client or your operating system.” Scroll down to see three known problems that may occur if you do not uninstall older versions first.

- **Close open programs on your workstation.**  
Also close any programs that run in the background, such as screen savers, and those that run automatically when you start Windows (check **Start > Programs > Startup**).
- **Disable anti-virus programs.**
- **Check the previous section to be sure you meet system requirements.**
- **Be sure that you are logged on to your workstation with local administrator privileges.**
  - Local administrator-level rights are required for both (1) installing .NET Framework 4 Extended (whether installed with the client or separately) and (2) installing the Connexion client only under Windows Vista or Windows 7.
  - For Windows 7, when you install (see step 7 in the instructions below), OCLC recommends that you right-click the downloaded file (\*.exe) and then click **Run as administrator**.
  - OCLC also **highly recommends** having administrator privileges to install the client-only software under Windows XP, although not strictly required.


### Download and install Connexion client

	Action
1	Open your Web browser to <a href="http://psw.oclc.org">http://psw.oclc.org</a> , and click <b>Software downloads</b> in the list of links on the left.
2	Type your OCLC authorization and password and click <b>Enter</b> .
3	<p>On the <b>Software downloads page</b>, double-click the link for one of the following:</p> <ul style="list-style-type: none"> <li>• <b>Connexion client 2.40 complete software</b> (with .NET Framework 4 Extended)</li> <li>• <b>Connexion client only software</b> (without .NET Framework 4 Extended)</li> </ul> <p>See more about which version of the software to download in the previous section.</p>
4	The OCLC Software License Agreement opens. You must accept the terms of agreement to download the software. At the end of the page, click the button next to <b>I Agree</b> .
5	In the <b>File Download</b> window, click <b>Save</b> to save the download file to your workstation or to a server.
6	In the <b>Save As</b> dialog, expand the <b>Save in</b> list, and select a location to save the file. Then click <b>Save</b> . Remember the location for the next step, or click <b>Open Folder</b> after the download is complete. You can now close the browser.
7	<p>Start setup and install the Connexion client:</p> <p>In Windows Explorer, navigate to the folder where you saved the downloaded file.</p> <p>Double-click the client <b>*.exe</b> file or highlight it and press &lt;Enter&gt;.</p> <p><b>Or</b></p> <p>If you have Windows Vista or Windows 7, right-click the <b>*.exe</b> file, and in the pop-up menu, click <b>Run as Administrator</b> to help prevent possible problems with installing.</p> <p>The setup program starts automatically.</p>

	Action
8	<p>Follow prompts to complete the installation.</p> <ul style="list-style-type: none"> <li>• <b>For most users, accept the default settings</b> throughout installation. In most windows of the Setup program, simply click <b>Next</b>.</li> <li>• In the <b>License Agreement</b> window, click the button next to <b>I Agree</b>, and then click <b>Next</b>. You must re-confirm that you accept the license to install the program.</li> <li>• In the <b>Select Installation Folder</b> window: <ul style="list-style-type: none"> <li>— Keep the default location for installing on your workstation: <b>X:\Program Files\OCLC\Connexion\</b>, where X = letter of your hard drive. Click <b>Next</b>.</li> <li>Or</li> <li>Enter a different path name or click <b>Browse</b> to select a location, such as a folder on a server for installing to multiple workstations, and then click <b>Next</b>.</li> <li>— Designate installation for: <ul style="list-style-type: none"> <li>- <b>Just Me</b> if you are the only one who will use the client on the workstation</li> <li>Or</li> <li>- <b>Everyone</b> if others will also use the client on the workstation</li> </ul> </li> </ul> </li> </ul> <p><b>Caution:</b> Be sure to make the same selection each time you upgrade to the next client version. Otherwise, the upgraded client is inoperable, and you must uninstall and then re-install.</p> <p><b>Note:</b> This selection is unavailable if you are not logged on as administrator. — <b>Optional.</b> Click <b>Disk Cost</b> to see available disk space and amount of disk space required.</p>
9	<p><b>Optional.</b> To cancel installation any time, click <b>Cancel</b> and then click <b>Yes</b> to confirm. To resume installation after cancelling, start the process over from the beginning.</p>
10	<p><b>Important!</b> When installation is complete, shut down and restart your workstation before running the client.</p> <p><b>Note:</b> The installation program adds the Connexion client icon to your desktop: .</p>

**Note on .NET Framework 4 Extended:** If the client installs or upgrades .NET to .NET Framework 4 Extended, you get a message that the prompts to install the client may be delayed by several minutes.

**Start the client**

Action
<p>On the Windows <b>Start</b> menu, click <b>Programs</b> [or <b>All Programs</b>, depending on your version of Windows] &gt; <b>OCLC Connexion Client 2.40</b>.</p> <p>Or</p> <p>On the desktop, double-click the Connexion client shortcut icon: .</p>

**When you open the client:**

- When you first open the client after installing for the first time, the **Choose Interface Language** window may open so that you can select an interface language. Accept the default or select a language.
- Occasionally, a **New Components Available** dialog opens so that you can download files containing small changes in the client configuration without having to install a new version. Click **Yes** to download the files immediately or click **Remind me later** to download later.

The new components will be included automatically in the next client version when you upgrade.

All downloadable files are placed in **X:\Documents and Settings\[user name]\Application Data\OCLC\Connex\**.

**Uninstall the client**

OCLC highly recommends that you uninstall before you upgrade. To uninstall:

	<b>Action</b>
1	Click the Windows <b>Start</b> menu, and then click <b>Control Panel &gt; Settings &gt; Add/Remove Programs</b> [or <b>Control Panel &gt; Programs and Features</b> , depending on your version of Windows].
2	Scroll the list of programs installed and select <b>OCLC Connexion client</b> .
3	Click <b>Remove</b> [or <b>Uninstall</b> , depending on your version of Windows] and then click <b>Yes</b> to confirm.  <b>Note:</b> If you previously upgraded the client to a newer version without first uninstalling, you may have more than one entry for the OCLC Connexion client. If so, remove all entries.

## 4 Install RLIN21 Arabic, Cyrillic, Hebrew or Latin keyboards

### About keyboards for entering script data in the Connexion client

- **RLIN21 Arabic, Cyrillic, and Hebrew keyboards:**
  - RLIN21 keyboards.** RLIN21 Arabic, Cyrillic, and Hebrew keyboards were previously created by RLG for use with RLIN21. The Connexion client supports the keyboards to assist catalogers who formerly used RLIN21.
  - Windows input keyboards.** The client also supports using Microsoft Windows input keyboards to enter these scripts. Catalogers can continue using Windows keyboards or install and use RLIN21 keyboards.
  - Difference:** RLIN21 keyboards include characters specific to each script. Microsoft keyboards include characters specific to a language written in a particular script.

**Example:** Using the single RLIN21 Arabic keyboard, generate Arabic script characters for Arabic, Persian, and Urdu instead of switching among separate Microsoft keyboards for each language to enter script data.

**Note:** For Chinese, Japanese, and Korean (CJK), you must use Windows Input Method Editors (IMEs). For other supported scripts (Bengali, Devanagari, Greek, Tamil, and Thai), use Windows keyboards. See also, Cataloging, International, “Windows provides input methods for using non-Latin scripts.”

- **RLIN21 Latin keyboard:**
  - Catalogers who formerly used RLIN21 can also install the RLIN21 Latin keyboard with RLIN21-equivalent keystroke shortcuts to enter diacritics and special characters (see the URL location of a list of these keys at the end of this section).
  - Client has a built-in function.** Alternatively, use a window in the client to enter diacritics and special characters:  
Click **Edit > Enter Diacritics**, select the image or name for a character, and click **Insert**; or use assigned client keystrokes (see a complete list of client assigned keys in **View > Assigned Keys**).
  - The client supports both methods of entering diacritics and special characters.

### Install an RLIN21 keyboard

#### Notes:

- You must have local administrator rights for your workstation to download and install the RLIN21 keyboards.
- After installing, you must make an installed keyboard available on your workstation—that is, select it under the **English (United States)** input locale for your workstation—before you can use the keyboard.

To install a keyboard:

	Action
1	Open your Internet browser to <a href="http://psw.oclc.org">http://psw.oclc.org</a> , and click <b>Software downloads</b> in the list of links on the left.
2	Type your OCLC authorization and password and click <b>Enter</b> .

	Action
3	<p>On the <b>Software downloads</b> page, click the link for one of the following:</p> <ul style="list-style-type: none"> <li>• <b>RLIN21 Arabic keyboard</b> (downloads <b>ARBr21.exe</b> file)</li> <li>• <b>RLIN21 Cyrillic keyboard</b> (downloads <b>CYRr21.exe</b> file)</li> <li>• <b>RLIN21 Hebrew keyboard</b> (downloads <b>HBRr21.exe</b> file)</li> <li>• <b>RLIN21 Latin keyboard</b> (downloads <b>LATr21.exe</b> file)</li> </ul>
4	<p>Scroll to the end of the OCLC Software License Agreement and click <b>I Agree</b>.</p>
5	<p>In the <b>File Download</b> window, check the <b>*.exe</b> file name to be sure you are downloading the keyboard you want, and then click <b>Save</b>.</p>
6	<p>In the OCLC Software License Agreement window, click <b>I Agree</b> to confirm your acceptance of the agreement.</p>
7	<p>In the <b>Save as</b> window, expand the <b>Save in</b> list if needed to navigate to the folder where you want to save the file. Select the folder, and then click <b>Save</b>.</p> <p>The window title changes to <b>Download Complete</b>. A message in the window also confirms that the file is downloaded.</p> <p>You can now close the browser.</p>
8	<p>In Windows Explorer, navigate to the folder where you saved the <b>*.exe</b> file. Double-click the file or highlight it and press &lt;Enter&gt;.</p> <p>You receive an <i>Installation Complete</i> message. Click <b>Close</b>.</p>
9	<p>Repeat this procedure to install additional RLIN21 keyboards if needed.</p>
10	<p>Shut down and restart your workstation before you use the keyboard(s).</p>

**Make an installed RLIN21 keyboard available for use**

After installing a keyboard, you must make it available for use in Windows. Instructions differ, depending on your version of Windows. Follow instructions on the Microsoft Web site for your version. To get Windows help:

- On the **Start** menu click **Help**. In the Help Search box, enter "input languages" and click the adjacent arrow to get a list of topics on input languages, input keyboards, Input Method Editors (IMEs), and more.

Or


- Go to the Microsoft Web site at <http://www.microsoft.com> and search the site for "input languages vista" or "input languages windows 7," for example.

**Caution:** You must make RLIN21 keyboards available for use under **English (United States)**. Do not install under any other language.

**Select an RLIN21 keyboard to input script data**

When you install languages and/or input keyboards or IMEs on your workstation, Windows provides a language bar on your desktop that you can customize, for example, by reducing it to a language indicator located in the system tray (bottom right corner of the desktop). Use the language bar or indicator to expand a list of your installed languages and keyboards and select one.

To select an RLIN21 keyboard for entering data:

	Action
1	Select <b>English</b> or <b>EN</b> in the language bar or indicator.  <b>Tip:</b> If you have multiple languages installed, use the Windows default keystroke shortcut <Left Alt><Shift> to toggle through the languages if needed.
2	Click the keyboard indicator (  ) and select the name of the RLIN21 keyboard you want to use.

**Caution:**

- While using the RLIN21 keyboards, you cannot use Connexion client default keystroke shortcuts mapped to characters that include the **Alt**, **Ctrl+Alt**, or **Ctrl+Alt+Shift** keys.
- These key combinations are used with the RLIN21 keyboards and override the Connexion client keystrokes when you are using an RLIN21 keyboard.
- However, Connexion client function keys and keystrokes assigned to characters that include the **Ctrl**, **Alt+Shift** and **Ctrl+Shift** keys remain available.

**Examples:**

The default keystroke for **Action > Delete Record**, mapped to <Ctrl><Alt><D>, conflicts with the RLIN21 keyboards (contains **Ctrl+Alt**) and cannot be used. You must map **Delete Record** to another keyboard shortcut.

However, you can continue to use the default keystroke for the delimiter character (<Ctrl><D>) and the default keystroke for **Action > Export** (<F5>), since they do not conflict with RLIN21 keyboards.

**Uninstall an RLIN21 keyboard**

**Caution:**

- To uninstall RLIN21 keyboards, you must have local administrator rights.
- You also must first remove the keyboard from your Windows regional and language options before uninstalling (next procedure). If you do not, when you uninstall, you receive an error message, "Fatal error during installation."

First, remove the keyboard from regional and language options:

	Action
1	Follow instructions for your version of Windows to open the regional and language options. For example, in Windows XP: 1. Click <b>Start &gt; Control Panel &gt; Regional and Language Options</b> . 2. Click the <b>Languages</b> tab. 3. Click <b>Details</b> .

	Action
2	In the list of language services available, under <b>English (United States)</b> , select the name of the RLIN21 keyboard you want to remove.
3	Depending on your version of Windows, click <b>Remove</b> or <b>Apply</b> , and then click <b>OK</b> .

Then, uninstall the keyboard program:

	Action
1	In Windows, click <b>Start &gt; Settings &gt; Control Panel &gt; Add/Remove Programs</b> .
2	In the alphabetical list of installed programs, scroll to the name of the RLIN21 keyboard that you want to uninstall and select it.
3	Click <b>Remove</b> . Click <b>Yes</b> to confirm.

## 5 Set up communications and log on




### Log on

You can customize the logon procedure in various ways (see below), for example, to set a default authorization and password.

Or

You can simply enter your authorization and password each time you log on to the OCLC system:

	<b>Action</b>
1	<p>Open the Connexion client:</p> <p>On the Windows Start menu, click <b>Start &gt; Programs &gt; OCLC Connexion</b>.</p> <p>Or</p> <p>On the desktop, double-click the Connexion client icon: .</p> <p><b>Notes on opening the client and the client interface language:</b> The first time you open the client or a new user profile, the Choose Interface Language dialog may open. Select one of the following languages, or accept the default:</p> <ul style="list-style-type: none"> <li>• Chinese (Simplified)</li> <li>• Chinese (Traditional)</li> <li>• English (<b>default</b>)</li> <li>• German</li> <li>• Japanese</li> <li>• Korean</li> <li>• Spanish</li> </ul> <p>Change the interface language any time in <b>Tools &gt; Options &gt; International</b>.</p>
2	<p><b>Occasional.</b> If new client components become available before the next version, a <b>New Components Available</b> dialog may open so that you can download files containing small changes in the Connexion client configuration without having to upgrade or install a completely new version.</p> <p>In the New Components Available dialog, click <b>Yes</b> to download the listed files immediately.</p> <p>Or</p> <p>Click <b>Remind me later</b> to download at another time. The window reopens each time you open the client until you download the files.</p> <p>Downloadable files listed in the window are placed in <b>X:\Documents and Settings\[user name]\Application Data\OCLC\Connex\</b> (where <b>X</b> represents the letter of your hard drive).</p>


	Action
3	<p><b>Two-step process:</b></p> <p>Click <b>File &gt; Log On</b>, or click , or press &lt;Ctrl&gt;&lt;F1&gt;. Log on using the Logon OCLC Connexion dialog, and then click a command that opens a dialog to interact with the OCLC system (for example, click <b>Cataloging &gt; Search &gt; WorldCat</b>).</p> <p>Or</p> <p><b>One-step process:</b></p> <p>Click any command that requires an online connection (for example, <b>Cataloging &gt; Search &gt; WorldCat</b>). The Logon OCLC Connexion dialog opens automatically. After you log on, the appropriate dialog opens (in the example, the Search WorldCat dialog) opens automatically.</p> <p><b>Alternative:</b> Select a macro or action to run automatically at startup that includes automatic logon using your default authorization and password. See “Run a startup macro or client action” below for details.</p>
4	<p>In the <b>Logon OCLC Connexion</b> dialog, enter your OCLC authorization and password using:</p> <ul style="list-style-type: none"> <li>• Hyphens: 123-456-789</li> </ul> <p>Or</p> <ul style="list-style-type: none"> <li>• No hyphens or spaces: 123456789</li> </ul> <p>Or</p> <p>Customize logon. See “Customize interactive logon” below.</p>
5	<p>Click <b>OK</b> or press &lt;Enter&gt;.</p>
6	<p>When the system logs you on, the Message of the Day opens.</p> <ul style="list-style-type: none"> <li>• To print the message, click <b>Print</b>.</li> <li>• To view the message later in the session or to view it after you log off, go to <b>View &gt; Message of the Day</b>. The client displays the Message of the Day from your last logon session.</li> </ul>
7	<p>Click <b>Close</b> or press &lt;Enter&gt; to close the Message of the Day.</p> <p><b>How do you know you are logged on?</b></p> <ul style="list-style-type: none"> <li>• If you logged on using a command other than <b>File &gt; Logon</b>, the appropriate dialog opens immediately.</li> <li>• The Logoff toolbar button () becomes available, and the Logon button () is unavailable (grayed out).</li> <li>• In the status bar, the online session timer starts. See “Customize automatic session timer and logoff warning” below.</li> </ul>

**Notes:**

- When you are logged on for cataloging, the client uses the classification scheme, holding library code, institution symbol, and (for NACO libraries) MARC Organization Code associated with your logon authorization. These settings are in **Tools > Options > General / Offline Cataloging Options**.

- You can open multiple copies of the client and log on using a different authorization/password for each copy if needed.
- You can also create different user profiles (**Tools > User Profiles**) that use different options settings and customizations to catalog for different libraries.

### Log off

	Action
1	<p>Click <b>File &gt; Log Off</b>, or click , or press &lt;Alt&gt;&lt;F1&gt;.</p> <p>How do you know you are logged off?</p> <ul style="list-style-type: none"> <li>• The Log Off toolbar button becomes unavailable (grayed out).</li> <li>• The Log On toolbar button becomes available.</li> <li>• The session timer no longer appears in the client status bar.</li> </ul> <p><b>Note:</b> After you log off, you can view the session duration and other information using <b>View &gt; User Information</b>.</p>
2	<p>Close the Connexion client:</p> <p>Click <b>File &gt; Exit</b>, or press &lt;Alt&gt;&lt;F4&gt;.</p> <p>Or</p> <p>Click <b>X</b> in the upper right corner of the client window.</p>

### Access setting suitable for most users is the default

- By default, the client is set up to connect to the OCLC system by Internet access (OCLC Default: <http://connexion.oclc.org>), the connection suitable for most users.
- System connection settings are in **Tools > Options > Access**.

### Specialized URL access

To specify a URL for access to the OCLC system other than the OCLC default::

	Action
1	Click <b>Tools &gt; Options</b> , or press <Alt><T><O>, and then click <b>Access</b> if not already on top.
2	Click the button for <b>Other URL</b> .
3	In the adjacent text box, enter the URL. The address you enter is displayed under <b>URL</b> at the bottom of the dialog.
4	When finished, click <b>Close</b> , or press <Enter> to apply the settings and close the Options dialog. Or Click <b>Apply</b> to apply the settings without closing the dialog.

### Optimize connection if your library uses proxy server(s) or a firewall

Check with your system administrator if you have trouble connecting to the OCLC system. If your library uses a proxy server or security firewall that may interfere with your connection, the client offers several options:

- Enter proxy server settings in the client.
- Set a persistent connection to keep the same TCP connection active to handle multiple requests.

To use these options:

	Action
1	<p>In <b>Tools &gt; Options &gt; Access</b>, click the <b>Use a proxy server to connect</b> check box, and enter your IP address and port number in the adjacent text boxes.</p> <p><b>Notes:</b></p> <ul style="list-style-type: none"> <li>• If you do not know this information, ask your system administrator.</li> <li>• Connexion client uses Windows proxy settings as its default settings. Even if the <b>Use a proxy server to connect</b> check box is not selected, but Windows settings point to a proxy server, the client will use these proxy settings for your OCLC connection. To find Windows proxy settings, go to <b>Start &gt; Settings &gt; Control Panel &gt; Internet Options &gt; Connections</b> and click <b>LAN Settings</b>.</li> </ul>
2	<p>If your proxy server requires user authentication, click the check box to <b>Use proxy server</b> and enter your user ID, password, and domain name (password appears as asterisks when you enter it).</p>
3	<p><b>Optional.</b> If you use a proxy server to connect to the OCLC system, and you have problems logging on:</p> <p>Click to select the <b>Persistent Connection</b> check box.</p> <p><b>Result:</b> Extends an HTTP session, keeping the same TCP connection active throughout multiple requests from your workstation (works like a KeepAlive extension to HTTP).</p>
4	<p>When finished, click <b>Close</b>, or press &lt;Enter&gt; to apply the settings and close the Options dialog. Or Click <b>Apply</b> to apply the settings without closing the dialog.</p>

**Customize interactive logon**

Go to **Tools > Options > Authorizations**. Logon setup options include:

- No customization: Enter authorization and password each time you log on
- Enter up to 10 authorizations (creates a list that you can open in the Logon OCLC Connexion dialog)
- Password-protect logon by entering an authorization but leaving the password blank
- Assign names to authorizations (not required)
- Set a default authorization
- Select no default authorization
- Assign a separate authorization to a local file for logon and for batch processing

**Note:** None of the options listed above are required, except that you must set a default interactive authorization or local file authorization if you run batch processing or if you run a startup macro or action that requires logon.

To set up any of the logon options:

	Action
1	<p>Click <b>Tools &gt; Options</b>, or press &lt;Alt&gt;&lt;T&gt;&lt;O&gt;, and then click <b>Authorizations</b>. Or Click <b>File &gt; Log On</b>. In the <b>Logon OCLC Connexion</b> dialog, click <b>Setup Authorizations</b>.</p>
2	<p><b>Enter up to ten authorizations:</b></p> <ol style="list-style-type: none"> <li>In the Authorizations page, in a text box under <b>Authorization</b>, type your OCLC authorization using: <ul style="list-style-type: none"> <li>— Hyphens: 123-456-789</li> <li>Or</li> <li>— No hyphens or spaces: 123456789</li> </ul> </li> <li>In the adjacent text box, under <b>Password</b>, type the password for the authorization. The password does not display. It is masked by asterisks (***) <b>Result:</b> You can select any authorization from the list in the Logon OCLC Connexion dialog each time you log on.</li> </ol>
3	<p><b>To password-protect logon:</b> In step 2, leave the password blank. Anyone who logs on must enter the password each time.</p>
4	<p><b>To assign an identifying name to authorizations:</b> In the adjacent text box, under <b>Name</b>, type a name for the authorization.</p> <p><b>Restriction:</b> Do not use opening or closing parentheses in names.</p> <p><b>Result:</b> When you log on, the box in the Logon OCLC Connexion window lists the authorization name first, if you entered a name (not required), followed by the authorization number in parentheses. The authorization number appears in parentheses whether or not you give it a name.</p>
5	<p><b>To set a default general authorization:</b> Under <b>Default</b>, click the button for the authorization/password you want to use as the default. (A dot in the adjacent button indicates the default selection.)</p> <p><b>Result:</b> The client supplies the default authorization and password automatically in the Logon OCLC Connexion dialog when you log on or when you run batch processing.</p> <p><b>Tip:</b> Even if you set a default authorization, the Logon OCLC Connexion dialog provides a list of all authorizations you enter. Select any authorization from the list (you do not have to change the default).</p> <p><b>Exception:</b> For interactive logon or batch processing using a local file, the client uses the authorization/password for that file, if you assigned one via <b>File &gt; Local File Manager</b>.</p>
6	<p><b>To select no default authorization:</b> Click to select <b>No Default Authorization</b> to leave the authorization and password boxes empty when you open the Logon OCLC Connexion dialog.</p> <p>Each time you log on, type an authorization/password or select one from the list of authorizations you entered.</p>
7	<p>When finished, click <b>OK</b> to save your settings and close the dialog, or click <b>Apply</b> to apply your settings and leave the dialog open. Or Click <b>Cancel</b> to cancel your changes.</p>

**Default logon authorization for batch processing (required)**

- **Required.** To run batch processing, you must define either:
  - A default general authorization (**Tools > Options > Authorizations**)
  - Or
  - A default authorization specifically for a local file (**File > Local File Manager**).
- If you enter an authorization/password for a local file:
  - The client overrides any general default authorization/password you set up in **Tools > Options > Authorizations** and uses the one you assigned to that local file.
  - The authorization/password for the local file is always listed first in the Logon OCLC dialog list (facilitates batch processing), whether or not you have the local file open.
- If you do not enter an authorization/password for a local file, the client uses the general default authorization/password you set in **Tools > Options > Authorizations**, when you log on or run batch processing using the file.

**Notes:**

- **Local files, logged on.** When you are logged on, the client uses the classification scheme, holding library code, institution symbol, and (for NACO libraries) MARC OrganizationCode associated with your logon authorization.
- **Local files, offline. Required.** When you are working in local files offline, the client uses the classification scheme, holding library code, institution symbol, and NACO MARC Organization Code that you specify in **Tools > Options > General**. You must set these options to be able to catalog offline.
- **Local files, label printing.** For label printing, the client uses settings such as automatic stamps and tags for pocket labels from **Tools > Options > Printing**, whether you are logged on or offline.

**Run a startup macro or client action**

To run a macro or start a client action automatically when you open the client, set an option:

	<b>Action</b>
1	Click <b>Tools &gt; Options</b> , or press <Alt><T><O>, and then click <b>General</b> .
2	Click <b>Startup Options</b> .
3	Click a button to select a startup option: <ul style="list-style-type: none"> <li>• <b>None (default)</b></li> <li>• <b>Run a macro</b></li> <li>• <b>Start a client function</b></li> </ul>

	<b>Action</b>
4	<p>If you select <b>Run a macro</b>, click the arrow in the macro list to display all of your client macros and select one. Or If you select <b>Start a client function</b>, click the arrow to display a list of the most likely commands you would run at startup and select an action.</p> <p><b>Note:</b> Actions that require logging on, such as <b>Logon + Search WorldCat</b>, have several steps:</p> <ol style="list-style-type: none"> <li>1. The client automatically logs you on:               <ul style="list-style-type: none"> <li>— Via a default authorization for the default bibliographic local file, if you set one (<b>File &gt; Local File / Authorization</b>).</li> <li>Or</li> <li>— Via your general default authorization (<b>Tools &gt; Options &gt; Authorization</b> page), if no local file default authorization is set.</li> <li>Or</li> <li>— If no default local or general authorization is set, the client gives you an error message and opens the Logon dialog. You must log on manually.</li> </ul> </li> <li>2. After logon, the Message of the Day opens. Click <b>OK</b> to close it.</li> <li>3. Then the client automatically opens the next dialog (such as the Search WorldCat dialog).</li> </ol>
5	Click <b>OK</b> to keep your settings or <b>Cancel</b> to cancel changes you made.
6	In the General Options page, click <b>OK</b> to save changes you made, or click <b>Cancel</b> to cancel changes, or click <b>Apply</b> to save changes and keep the Options dialog open.

**Automatic logoff for inactivity**

- The client automatically logs off your online session after 39 minutes if you have not interacted with the system.
- You can check the digital timer display in the client status bar to see the time remaining on the inactivity timer. When you interact with the system, the timer resets and restarts the countdown.

**Example:**

*14:30* (shows that you have 14 minutes and 30 seconds till automatic logoff unless you interact with the online system).

- When you take an action on a record or do a search, the inactivity counter for the current session resets to the maximum 39 minutes (or to the number of minutes you select in **Tools > Options > General / Session Timer Options**).
- The following interactions with the system reset the timer:
  - Retrieving any type of record online via searching or browsing
  - Saving any type of record to an online save file
  - Showing the default online constant data or showing online save file statuses
  - Controlling headings (but not uncontrolling)
  - Applying online constant data
  - Validating records while logged on (note that you can also validate records offline)

- Taking OCLC actions on records immediately while online (commands on the Action menu or Holdings submenu, such as Update Holdings, Produce or Alternate Produce, etc., except Set Status)
- Batch processing searches and/or record actions
- Viewing holdings
- Viewing the next or previous 100 records from a search results list

**Customize automatic session timer and logoff warning**

Use the following procedure to:

- Shorten the time before automatic logoff
- Display or hide the timeout warning message
- Change the timing of the warning message

	<b>Action</b>
1	Click <b>Tools &gt; Options</b> , or press <Alt><T><O>. Then click <b>General</b> .
2	Click <b>Session Timer Options</b> .
3	Select the number of minutes of inactivity before the client automatically logs you off the system. Or Highlight the number of minutes in the box and type a number.  <b>Default:</b> 39 min. <b>Range:</b> 5 to 39 min.
4	Click to select or clear the <b>Warn</b> check box to display or hide the timeout warning.  <b>Default:</b> Check box selected; warning displays.
5	In the Warn time list, select the number of minutes before automatic logoff to display a warning. Or Highlight the number of minutes in the box and type a number.  <b>Default:</b> 5 min. <b>Range:</b> 1 to 9 min.  <b>Caution:</b> You cannot set the timer and warning options to the same number of minutes. If you do, the client gives you an error message.
6	Click <b>OK</b> to save your settings or <b>Cancel</b> to cancel changes.
7	In the General Options page, click <b>OK</b> to save changes you made and close the Options dialogs, or click <b>Apply</b> to apply the setting without closing the dialog.

### View session information

To view current session information while logged on, or to view session information from your last logon session after you log off:

Action
<p>Click <b>View &gt; User Information</b>.</p> <p><b>Result:</b> The User Information window opens, showing:</p> <ul style="list-style-type: none"><li>• Session ID (for current session if logged on or for the last session)</li><li>• Institution symbol</li><li>• Classification scheme</li><li>• MARC Organization Code (NACO participants)</li><li>• Cataloging level</li><li>• Authorities level</li><li>• Local Holdings level</li><li>• Profiled for institution records (Yes or No)</li><li>• OCLC logon time</li><li>• Local logon time</li><li>• Current local time</li><li>• Name of default online bibliographic constant data</li><li>• Name of default local bibliographic constant data</li><li>• Name of default online authority constant data</li><li>• Name of default local authority constant data</li><li>• Session duration</li></ul>

### System responses for troubleshooting

The Access tab (**Tools > Options > Access**) contains check boxes for selecting or clearing options to collect response times and/or exact requests and responses during interactions with the OCLC system.

- **Enable statistics logging option.** Allows the client to log response times between your workstation and the OCLC system, if responses reach a certain (variable) length of time. **Default:** Check box selected.
- **Enable transaction logging option.** Allows the client to log exact requests and responses between your workstation and the OCLC system when you interact with the system. **Default:** Check box cleared.

Collecting this information can assist OCLC staff to evaluate system performance, if needed.

**Note:** OCLC recommends keeping the default settings for these two options, unless advised otherwise by Connexion support staff for problem solving.

Any statistics and/or transactions logged are stored in **X:\Documents and Settings\[user name]\ApplicationData\OCLC\Connex\HostResponse.log**.

## 6 Update the client

### Update the Connexion client to version 2.40

- Currently, versions 2.10, 2.20, and 2.30 are supported in addition to version 2.40. The end-of-life date for all previous versions —2.10, 2.20, and 2.30—is **October 1, 2012**.
- **After that date, you will be unable to log on to the OCLC system with any version except 2.40.**
- If you do not upgrade after release of version 2.40, you will receive a reminder message each time you open the client software, starting 30 to 60 days before the end-of-life date for the previous versions. You can bypass this reminder and continue using a previous client version until October 1, 2012.
- **Recommended: Uninstall before upgrade:** OCLC recommends that you uninstall your current version of the client before upgrading. See “How to uninstall the client” at the end of section 3 of this Guide.
- When you uninstall, with the possible exception of customized macros in OCLC-provided macro books (please see the **Caution** below), the client keeps your previous settings, customizations, and local files. You do not need to restore options or files after upgrading.
- After uninstalling, to install version 2.40, follow directions in section 3 of this Guide.
- To check that your upgrade to version 2.40 was successful.
  - Open the client and click **Help > About OCLC Connexion Client**.
  - At the top of the General tab in the About OCLC Connexion Client window, verify that the version number is 2.40.xxxx.xxxxx (x = any number).
- See “Connexion client problems” for any issues with upgrading at: [http://www.oclc.org/connexion/support/client\\_known\\_problems.htm#upgrading](http://www.oclc.org/connexion/support/client_known_problems.htm#upgrading)

**Caution: OCLC-supplied macro books may be overwritten**

**Before you upgrade:** If you stored macros you created in either of the OCLC-supplied macro books, **OCLC.mbk** or **Dewey.mbk**, rename the existing macro book so that it will not be overwritten. It is better to avoid storing any of your own macros in these two books. When you upgrade the client or when a new OCLC macro book becomes available, your existing OCLC macro books are overwritten, and you lose any customized macros that you stored there.

**OCLC recommends** that you create your own macro book files to store macros you create, copy, or record, rather than adding them to OCLC-supplied macro books. Especially, do not add macros to **OCLC.mbk**.

**Changes and enhancements in version 2.40**

### View GLIMIR clusters in WorldCat search results

- Set an option to show search results in GLIMIR (**G**lobal **L**ibrary **M**anifestation **I**dentifier) clusters of WorldCat bibliographic records that have different languages of cataloging for the same work (called “parallel” records).

**Note:** If you use the quick search obx on the client toolbar, a new check box on the quick search drop-down lets you change your GLIMIR setting without having to open the Search WorldCat window.

- Show the GLIMIR cluster for any displayed bibliographic record by using a new menu item **Cataloging > Show > All GLIMIR Cluster Records**.

### Automatic classification tool

- Use the new **Classify** command on the Edit menu to automatically insert a suggested Dewey or Library of Congress classification number in a displayed record for a book, DVD, CD, or other material type in a field you specify.

The new command uses the FRBR-based, prototype OCLC Classify Web service at <http://classify.oclc.org/> to provide a classification number from a WorldCat record with a matching standard number in this order: OCLC number, ISBN, ISSN, UPC, LCCN.

**Note:** A new macro command, GetClassNumber, was added for this functionality for those who use macros. See "Macro changes" below.

### RDA workforms

- Set an option in the client using **Tools > Options > RDA** (formerly "RDA Toolkit") to use RDA versions of the existing AACR2 workforms to create bibliographic and/or authority records and constant data.

Existing workforms open by default when you create new records or constant data, unless you set the RDA workform option(s).

- Set the option separately for bibliographic and/or authority workforms (also applies to creating bibliographic and authority constant data records).

### RDA logon option

- If your RDA Toolkit subscription includes access via IP authentication, you can select an option in Tools > Options > RDA to have the client use it, instead of a user name and password, to log on for the RDA Toolkit field descriptions.

### 264 field in WorldCat search results

- Record descriptions in a brief or truncated list of WorldCat search results include data from the 264 field, if present in the record and if no field 260, 261, or 262 is present. Field 264 contains RDA production, publication, distribution, and manufacture information.

**Note:** Field 264 will be implemented in the MARC Update 2012 system installation. OCLC will make an announcement when MARC Update 2012 is completed.

### MARC update 2011 changes

- New indexes added since the last client release are in the drop-down index lists in search and/or browse windows, as appropriate.
- Language names are updated in:
  - The **Language** and **Language of Cataloging** drop-down lists in the Search WorldCat window.

- The **Language** drop-down list in the Search Online Heritage Printed Book (HPB) Database (if the HPB menu is activated in Tools > Options > Heritage Printed Book).

### Macro changes

- A new macro command is available—GetClassNumber—for the new **Edit > Classify** functionality.
- Two new OCLC-supplied macros are available:
  - ClearELvl3Workform**—This macro deletes all but the system-supplied fields from a minimal encoding level 3 bibliographic record and replaces them with workform data, so that enhancing the record is more like doing original cataloging. The workform data blends two sets of workforms—AACR2 and RDA.
  - GenerateERecord**—This macro creates a workform to represent an online version of an item based on the print, microform, or another format version of a bibliographic record for the same title.

**Note:** The GenerateERecord macro **replaces** the following two OCLC macros: GenerateESerial and GenerateESerialCONSER.

OCLC macros are stored in the OCLC.mbk macro book. Please see the **Caution** above about not storing your own macros in OCLC macro books, which are overwritten when you upgrade the client.

### Additional authorities system changes

The following system changes were installed in February 2012 and are functional in all currently supported versions of Connexion, unless otherwise noted:

- For **Edit > Control Headings > Single**: If there is a value in field 040 Ꞥb but the value is not **eng**, description heading fields (1xx, 7xx, 8xx) cannot be controlled.
  - Note:** This change applies only to version 2.40 of the client.
- For **Edit > Control Headings > All**, the system:
  - Uncontrols invalid controlled headings (descriptive name headings and/or subject headings).
  - Automatically checks for an updated version of the heading text and updates the text if needed.
  - Automatically updates a previously fully or partially controlled heading with punctuation-only changes.
- Change to accommodate RDA: Field 7xx with first subfield Ꞥi followed by Ꞥa is controllable, but **only in version 2.40** of the client.

**Note:** For controlling headings, the system uses the established form in field 1xx of the authority record.

### Changes in version 2.30 from versions 2.10 and 2.20

**If you did not upgrade from versions 2.10 or 2.20 to version 2.30** before upgrading to 2.40, please be aware of the following additional changes that were made in version 2.30:

#### **Windows 2000 no longer supported**

- With this version, Connexion client is no longer supported for use with Windows 2000. The client is supported for use with 32-bit and 64-bit versions of Windows XP (Home and Professional), Windows Vista, and Windows 7.

#### **Links to RDA Toolkit**

- Connexion users who subscribe to the RDA Toolkit can link from a displayed bibliographic or authority record to field descriptions in the RDA Toolkit using **Tools > RDA Toolkit**.
- A subscription to the RDA Toolkit is required to use this feature. Subscribers enter their authorization and password in **Tools > Options > RDA**.

**Note:** Several MARC fields are not covered by RDA instructions. For these fields, you will receive this message: "MARC Element Not Found."

#### **Display of 029 fields**

- 029 fields are relocated to the bottom of bibliographic records for display in the client but remain at the top of the record for export to your local system.

#### **Language of cataloging limiter in Search WorldCat window**

- Users can limit WorldCat searches by language of cataloging by selecting a language in the Search WorldCat dialog.
- The setting is retained across logon sessions until you change it.
- The limiter applies to the Command Line and Keyword/Numeric areas of the Search WorldCat dialog and to the quick search box on the toolbar.

#### **Language of cataloging display in search results**

- A **CatL** column is added to the Column Settings list in the local bibliographic save file search results.
- The language of cataloging displays in the local file and WorldCat truncated lists by default.
- The language code displayed is based on data in the 040 \$b of the record. If no 040 \$b exists, the cell is blank.

#### **Increase in the maximum number of batch searches to download from 100 to 150**

- In **Tools > Options > Batch**, the **Maximum Number of Matches to Download** is now 150.

### Option to allow export of workforms

- Users can explicitly turn on an option to export workforms before the records are added to WorldCat or to the Authority File using a new check box called **Allow export of workforms** in **Tools > Options > Export**.
- By default, the setting is unchecked (cleared). If checked, the **Action > Export** command is enabled if the active record is a workform.

### New export/import support for MARCXML

- In **Tools > Options > Export > Record Characteristics**, you can select **MARCXML** as the **Record Standard** for exporting records.
- In **File > Import Records > Record Characteristics**, you can select **MARCXML** as the **Record Standard** for importing records.

### Changes related to pre-2011 MARC updates

- Several language names are added to the Search WorldCat dialog drop-down list.
- Some language names that have changed are updated, and a few obsolete languages are removed from the Search WorldCat drop-down list.
- Additional indexes are in the appropriate search and/or browse drop-down lists in the WorldCat and Authorities search windows.
- New material types for Blu-ray Discs, U-matic, NTSC, and ATSC are added to search drop-down lists.
- A new element, "Form of item," has been added to the fixed field display in the Computer File workform and in the Computer File 006 Guided Entry box.

### Sorting changes

- In the 6xx field range, subject headings in 600-651 sort first followed by other 6xx fields in tag order.
- In the 7xx field range, added entries in 700-740 sort with personal names first (fields 700, 790, 796), followed by corporate and meeting names second (fields 710, 711, 791, 792, 797, 798), followed by uniform titles third (fields 730, 793, 799). Remaining 7xx fields including 760-787 linking fields sort in order by tag.
- In the 8xx field range, series entries sort first (fields 800, 810, 811, 830), followed by fields in the 840-879 range as input, followed by other 8xx fields in tag order.

### Macro changes

- A new macro command is available, InsertFromCitedRecord.
- The following are changes to OCLC-supplied macros:
  - The OCLC macro book (**OCLC.mbk**) has a new macro **Add33x**, which will add fields 336, 337, and 338 in an RDA record via a menu.
  - Existing macros **Add&Edit007**, **AddAuthority6xx**, **AddSerialNotes**, and **Generate891** reflect changes to the MARC format.
  - A few other macros have minor changes.
  - New 007 codes have been defined for Kit, Notated Music, Text, and Unspecified and are in the revised Add&Edit007 macro. These codes became available with the 2011 MARC update system installation.
- Please see the “**Caution**” above about not storing your own macros in OCLC macro books, which are overwritten when you upgrade the client.

### Authority control

- Users can control Library of Congress (LC) genre headings tagged 655 with second indicator 7 and with the code **lcgft** in subfield 2.
- Users can no longer control headings tagged 6XX with second indicator 4.

### Connexion digital import (Attach Digital Content feature)

- Collection list fully expands so the entire CONTENTdm collection title is visible.
- Collection list “remembers” and pre-selects the last collection used with a record.
- File selection now defaults to “all files.”

### Problem resolution

**Note:** The name of the Hand Press Book database changed to Heritage Printed Book.

## 7 User files

### User settings and customization files

The Connexion client stores your data files in one folder, **MyProfile**, in the following location:

**X:\Documents and Settings\[user name]\Application Data\OCLC\Connex\Profiles\MyProfile\** (X = the letter of your hard drive)

The following table describes settings and customization files:

File name (default)	Purpose of file
Custom.Keymap.xml (or other .Keymap.xml files you create)	Stores customized keystrokes that you assign in <b>Tools &gt; Keymaps</b> . When you use a keystroke shortcut, the client carries out any action you assigned to the shortcut. If you did not assign an action, the client carries out the preassigned action.
AppExclusions.Keymap.xml	Stores individual default keystroke shortcuts that you unassign. The client uses the file to restore a single default keystroke when you reassign it.
Options.xml	Contains most of your option settings and customizations; for example, those from <b>Tools &gt; Options</b> tab pages, local file settings, customized toolbar, stored previous searches for all search dialogs, and other information unique to the way you use the client.
TextStrings.xml	Stores text strings you create to enter data that is often repeated in records ( <b>Tools &gt; Text Strings</b> ).
user.dic	User dictionary for the spell checker. To customize the dictionary, go to <b>Tools &gt; Options &gt; Spelling</b> and click <b>Edit User Dictionary</b> .
UserLogonInfo.xml	Stores your user logon information from the current or most recent online session (in the client, opens via <b>View &gt; User Information</b> or <Ctrl><Alt><U>)
WebLinks.xml	Contains automatic updates to the client that do not require a complete application upgrade.

### Notes:

- **Caution for copying the MyProfile folder:** You can copy option settings to another locations for backup or copy to another machine or to a network drive to share your settings and customization files. However, if you copy the option settings file, **Options.xml**, for sharing, either:
  - Set the local file locations to a folder that is common to all workstations
  - Or
  - Use a text editor such as Notepad or Textpad to remove the lines in **Options.xml** that define local file path and file names.

If you keep the local files in the default location, the path name includes the user name, which will differ for each workstation, and therefore cause problems.

- **Hidden files in XP.** By default in Windows XP, the **Documents and Settings** folder and its contents, including **MyProfile**, are hidden. To show hidden files in Windows XP:
  - a. Click the Windows **Start** menu and then click **Settings > Control Panel > Folder Options**.
  - b. In the View tab, under **Hidden files and folders**, select the **Show hidden files and folders** button.
  - c. Click **OK**.
- **Optional.** Create multiple user profiles to use different sets of settings, for example, to catalog for different libraries, using **Tools > Profiles**. Most users do not need multiple profiles. If you do, please note:
  - The settings and customizations that make up a new profile are stored in a separate profile folder that the client requires you to name, not in the **MyProfile** folder.

**Example:** You create a new profile and name the profile **NACoprofile**. The new profile is stored in **\...\Profiles\NACoprofile**.

  - Select the profile you want to use each time you start the client (if you set an option in **Tools > Profiles**).
  - Or  
Select a profile from **Tools > Profiles** anytime after the client is open.
  - If you have multiple user profiles, you may have an additional file called **Profile.xml** in the **\...\Connex\Profiles** folder. This file stores:
    - The setting for whether or not you want to be prompted to select a profile when you start the client
    - The default profile selection
  - See Basics, Set Options and Customize, "Create multiple user profiles" for more information.

**Default user data files**

The client supplies four default local files for saving records and constant data and three default files for printing records, labels, or accession lists to a file rather than to a printer. Use and re-use these default data files or create your own data files.

The default data files described in the following table are located in:

**X:\Documents and Settings\[user name]\Application Data\OCLC\Connex\Db**(Windows XP)

**X:\Users\[user name]\AppData\Roaming** (Windows Vista or 7)

Accessions.html	An accessions list prints to this file when you set the option <b>Output to File</b> in <b>Tools &gt; Options &gt; Printing</b> (click <b>Accessions List Options</b> ) and accept the default path and file name.

**User files are retained**

The Connexion client user files described in this section are always retained and reused each time you open the program and each time you upgrade to a higher version.

However, OCLC recommends retaining the option to have the client automatically back your files up.

**Caution:** Do not store any macros you create, copy, or record in the OCLC-provided macro files **OCLC.mbk** or **Dewey.mbk**. Create different macro files (called "books") to store your customized macros. **OCLC.mbk** or **Dewey.mbk** may be replaced when you upgrade to provide updated or new OCLC macros. If you have customized macros in these files, you will lose them.

**Copy files to back up or share**

To copy **MyProfile**, or one or more files in **MyProfile**, to another location to back up or share with others:

	Action
1	In Windows Explorer, select the <b>MyProfile</b> folder (or another profile folder you created) or any file(s) in the folder. <b>Note:</b> See <b>Caution</b> above for sharing option settings ( <b>Options.xml</b> ).
2	Right-click <b>MyProfile</b> or file(s) in <b>MyProfile</b> , and on the popup shortcut menu, click <b>Copy</b> . Or Press <Ctrl><C>.
3	Right-click the folder where you want to copy the <b>MyProfile</b> folder or file(s), and on the shortcut menu, click <b>Paste</b> . Or Select the folder where you want to copy the folder or file(s), and press <Ctrl><V>.

### Quick access to client files and logs

Instead of navigating in Windows Explorer to Connexion client files, folders, and troubleshooting logs, open them with a single click from within the client:

Action
On the View menu, click <b>User Information</b> (or press <Alt><V><U>), and then click <b>Paths and Logs</b> .
See more details in Basics, Get Support and Information, "Find user information for troubleshooting."

### Downloadable files (new components)

From time to time, when you open the client, a New Components Available window opens listing files you can download to get small changes in the Connexion client configuration without having to upgrade or install a completely new version. You can download immediately or be reminded later.

Downloadable files listed in the window are placed in **X:\Documents and Settings[user name]\Application Data\OCLC\Connex\** (where **X** represents the letter of your hard drive). For example, downloadable files in the Connex folder include:

## 8 Customize Connexion client

### Summary of options to check before you use the client

For the most part, after you install the Connexion client, you can log on to Connexion and start working immediately.

However, before using the client, you may need to check, enter, or change settings listed in this section, depending on which functions you use. For example, the following settings are **required** for batch processing, exporting records, and many more features (see details in the tables below):

- **Default authorization/password**

- **Optional** for logging on for online cataloging. The alternative is to enter an authorization/password each time you log on. To set a general-use default, go to **Tools > Options > Authorizations**.
- **Required** for logging on for batch processing. Either enter a default general-use authorization (**Tools > Options > Authorizations**) or enter a default authorization for each local file you use for batch processing (**File > Local File Manager**; click **Authorization**).
- **Required** if you select a startup option to run automatically when you open the client (**Tools > Options > General**; click **Startup Options**) (can use general default or local file default authorization).

- **Export destination**

- **Required** if you export records to your ILS (integrated local system) from the online system. To enter an export destination, go to **Tools > Options > Export**. For more information, see the *Setup Worksheet for Connexion Client* at:

- **Holding library code, institution symbol, and (for NACO participants) MARC organization code**

- **Required** for offline cataloging, if you want to create bibliographic and/or authority records while offline. Click **Tools > Options > General**, and then click **Offline Cataloging** to enter your information.

- **Batch delete holdings**

- **Required** settings in **Tools > Options > Batch** to successfully complete batch delete holdings actions:

When the check boxes are cleared, label printing and record export occur immediately, whether you are logged on or offline.

### Connexion service hours

Access to the OCLC system using Connexion is available 24 hours, Monday through Sunday.


**Note:** OCLC occasionally conducts maintenance on the system, most often on Sundays from 2 am to 6 am U.S. Eastern Time. OCLC usually provides advance notice about these maintenance periods via listserv messages and on the system alerts Web page.

### Check system alerts or known problems

To check the system alerts page for conditions affecting system performance, or to check client known problems:

- On the Help menu, click **Useful Web Links** and then click **OCLC System Alerts** or **Client Known Problems**.

### Search OCLC system news for a product or service

- Click **View > News**, or click , or press <Ctrl><F5>. In the Search Online News window, enter a search term, or leave search criteria blank to retrieve all news items. Then select a service category such as **Cataloging**.
