





End-to-End Archival Processing Flow



Assess Archival Backlog Survey Tools

IF Accurate census of processing backlog

THEN Standardized practice

- deliverables, encourage surveys, aggregate view
- ...survey existing instruments and practices including units of measurement
- ...identify the range of deliverables from these instruments
- ...recommend best practices including re-appraisal that would permit aggregation of results



IF determine what collections are currently described

THEN guidance on where to invest scarce resources

...Provide a system-wide view by geography

extent/size

...Determine descriptive data patterns for extensive collections

... Comparative studies?




IF understood application of existing norms AND understood what is valued and necessary

THEN changes in practice

...Define the State of Holdings and Description for Archives determine system-wide patterns which elements used – when, how often

...Analyze Existing EAD Creation and Editing Tools survey and report

...Define the State of "Hidden Collections" for Archives
US-centric effort
not described
described but not online
online but not disclosed



IF understood researcher, user and search engine requirements

THEN limit investment to description that optimizes


Analyze Specialized Archival Discovery Environments

...survey specialized discovery environments for archival materials

...analyze how descriptions flow into these environments

...synthesize search data from the environments to determine user behaviors and expectations

...determine optimal data and elements for success




IF understood successful delivery
